

20X EXTRA DATA PROMOTION TERMS AND CONDITIONS

These Terms and Conditions ("**Terms**") apply to the 20x extra data promotion ("**Promotion**") linked to the Family Perks programme. By taking part in this Promotion, you agree to be bound by these Terms, together with any other applicable Tesco Mobile terms and conditions, including (without limitation) your Pay Monthly Terms, the Family Perks Terms and Conditions, Fair Usage Policy and Tesco Mobile's general terms and conditions, as amended from time to time. 1. ELIGIBILITY

- 1.1 To be eligible for this Promotion you must purchase a new line or add an additional line to an existing contract from selected tariffs during the promotional period and you must be aged 18 years or older.
- 1.2 You must be a resident of the United Kingdom, Isle of Man, Jersey or Guernsey.
- 1.3 All customers are subject to Tesco Mobile's standard eligibility checks, which may include credit checks and identity verification. To help prevent fraud and money laundering, Tesco Mobile and its service providers may share information with fraud prevention agencies. 2. PROMOTION DETAILS

- 2.1 This Promotion runs from 18 May 2026 to 12 July 2026 ("**Promotional Period**")
- 2.2 The Promotion is available to new and existing Tesco Mobile customers who purchase a new or add an additional line to their existing Pay Monthly SIMO or handset during the Promotional Period. - 2.3 The Promotion allows customers adding an eligible line to select a 5GB, 10GB or 20GB per month extra data allowance ("**Data Allowance**") as a perk via the Family Perks programme.
- 2.4 The Data Allowance available to select via the Promotion varies depending on the monthly price of your tariff being added to the account.
- 2.6 The Promotion excludes Pay As You Go Essentials and 1 month rolling plans.
- 2.6 The Data allowance selected cannot be applied to lines which are not purchased or upgraded during the Promotional Period. The Data allowance will be applied on a monthly basis and may take up to 48 hours to appear on your account after your bill date.
- 2.7 The Data Allowance will remain available provided:
 - (a) There is at least one other active Tesco Mobile line on the same billing account.
 - (b) The monthly Data Allowance provided must be used within the applicable billing month and cannot be carried over to any subsequent billing month.
 - (c) You have not cancelled your new or additional line as set out in Section 3 below.

3. CANCELLATION

- 3.1 If you change your mind after you have purchased an additional line you can tell us that you would like to cancel during the Cooling-off Period of 14 working days as set out in here [Tesco Mobile Pay Monthly Service redline Terms and Conditions-June 2025.pdf](#)
- 3.2 After the cooling off period, you can cancel your contract anytime. To cancel contact Customer Care. Your cancellation will take effect on your next Billing Date. However, it takes up to 48 hours for us to process your cancellation, meaning you need to cancel at least 48 hours before your next Billing Date to ensure a further monthly Minimum Contract Period does not start. If a new Minimum Contract Period does start, your cancellation will automatically take effect on the following Billing Date.
- 3.3 The Data allowance will be lost if the eligible line benefiting from the Promotion is cancelled.

4.GENERAL

- 4.1 Tesco Mobile reserves the right to terminate and/or amend the promotion, along with these Terms at any time, upon reasonable notice.
- 4.2 Tesco Mobile reserve the right to limit the applicability of any particular offer to specific customers and may from time to time run different offers with different terms for different customers.
- 4.3 These Terms will be governed and construed in accordance with the Law of England and Wales.
